

Palm Responsible Sourcing Action Plan 2024 -2025



#### Introduction

In today's world, where environmental concerns and ethical practices are in the spotlight, responsible sourcing has become a critical aspect for businesses. This is especially true in the palm oil industry, which has faced significant criticism for its environmental and social impacts.

To address these challenges, in March 2015 ADM committed to its Policy to Protect Forest, Biodiversity and Communities. Since then, ADM made significant progress towards implementation which are articulated around four pillars:

- 1. Supply chain traceability
- 2. Supplier engagement
- 3. Monitoring & verification
- 4. Reporting

This document outlines a strategic framework for a responsible palm sourcing plan, accenting the actions for the period 2024-2025 and continuous improvement. By implementing this plan, ADM can demonstrate its commitment to environmental stewardship, respect for human rights, and the promotion of sustainable development in palm oil-producing regions. Through collective action and meaningful partnerships, we can navigate the complexities of the palm oil supply chain and pave the way towards a more sustainable and equitable future.

### Agriculture Sector Roadmap to 1.5°C

- The Agriculture Sector Roadmap to 1.5°C is a multi-stakeholders initiative gathering industry key actors, committing on activities to limit deforestation and land use change connected to deforestation-linked-commodities.
- Hindering deforestation will reduce land-usechange emissions and enable to keep the 1.5°C target in the Paris Agreement within reach and tackle food crisis risks.

- 3 Pillars of this sectoral voluntary commitment for palm:
  - Commodity Implementation Plan
  - Drive transformation of commodity producing landscapes
  - Support Forest positive sector transformation

It will imply increasing purchasing volumes from suppliers with good NDPE IRF score, encouraging suppliers to improve their NDPE IRF score, and require all suppliers to share their NDPE IRF profile. Monitor and verify suppliers to achieve responsible sourcing of palm oil.	ADM systematically pre-screens its potential future direct suppliers and current direct suppliers are assessed against industry best-practices.
