

ADM's Commitment to Protecting Forests, Biodiversity and Communities 2024 Palm Progress Report



Introduction

Since ADM committed to No Deforestation, No Peat, and No Exploitation (NDPE) in March 2015, ADM has been continuously reinforcing its commitment with actions and engagements, especially for the palm supply chain.

Palm generates revenue for millions of farmers, mostly located in Southeast Asia. ADM's sourcing requirements are defined in ADM's <u>Policy for Human-Rights</u> and <u>Policy to Protect Forests</u>, <u>Biodiversity and Communities</u>.

In addition to participation in multi-stakeholder initiatives (e.g. POCG, RSPO) and improved supplier engagement, ADM has been updating its documentations to reflect industry best practices.

- Policy Update Revision to integrate a No-Conversion commitment.
- <u>Palm Action Plan</u> Structured according to ADM 4 pillars (Traceability, Supplier & Stakeholder Engagement, Monitoring & Verification, Reporting), this action plan sets goals and provides guidance towards 2025 in alignment with the Agriculture Sector Roadmap to 1.5°C degrees.

This 2024 Palm Progress Report looks back at ADM progress in the last year and illustrates the approach detailed in the Palm Action Plan.

Reducing Emissions from Land Use Change

Supply Chain Traceability

ADM maintained its collaboration with direct suppliers and collected palm traceability to the mill and to the plantation information. This year again, an independent third party verified the reliability of the ADM-internal traceability protocol and accuracy of data collected.

ADM's supply chain counts around 1634 mills. To that extent, ADM contributes indirectly to the economic development of communities and inclusion of smallholders. An accurate traceability of the palm supply chain enables ADM to identify mills which could be located in regions exposed to risks of deforestation. In order to minimize risks violations of ADM policies, ADM assesses its suppliers to ensure suppliers have the necessary mechanisms in place to fulfill ADM's responsible sourcing standards.

Supplier Engagement

ADM has been making strong commitments on responsible palm sourcing and therefore needs to ensure the maturity of its palm suppliers in regards to Human Rights and Environmental Protections. Subsequently, direct palm suppliers, representing 93,5% of sourced volumes are annually assessed by a third-party on the robustness of their sustainability programs and ADM guides them towards industry best-practices.

Thriving Communities Conducted by Tzu Chi Foundation and GAR

ADM's partnership with the Tzu Chi Foundation was initiated in October 2023 and aims at developing childcare and community learning centers.

- Increasing access to childcare has immediate and long-term benefits for women, their families, businesses and economies. Mothers can work and grow family incomes while quality education and appropriate nutrition is provided to children. Those centers also offer parenting support groups to share experiences and strengthen the link with local communities.
- Community Learning Centers (CLC) organize workshops to provide education on environmental topics and actively prevent deforestation in Riau, considered a deforestation-risk area. CLCs also contribute to local economic activity by developing handcrafted goods to diversify community members' revenues.
- ADM Cares funding supports the operations of the CLC as well as salaries of child caregivers. ADM Cares financial support will contribute to financing costs for 12 centers over 3 years.







Monitoring & Verification

ADM implements a systematic supplier screening-, assessing-, and monitoring-program that ensures suppliers are compliant with ADM responsible sourcing requirements. This includes supplier's scorecarding and continuous satellite verification by third parties.

ADM Supply Chain Due Diligence Program

ADM committed to maintain high integrity standards across its supply chain. A significant assessment and engagement work is being done annually for existing suppliers. Moreover, potential new suppliers need to go through a demanding Due Diligence process covering:

- Company profile including NDPE Policy, certification, legality, and subsidiaries.
- Environment checking such as deforestation history and liability, water and/or air pollution, etc.
- Human rights checking such as, labor issue, land conflict, indigenous people, etc.
- Supply chain risk.
- Grievances status.
- Additionally, we also check internally based on the scorecard information (attached) and online news.

Palm Supplier Scorecard

The palm supplier scorecard is an annual assessment of direct suppliers about their Policies, Traceability, Supply chain implementation plan, Monitoring and verification program, Landscape and sectoral engagement, Grievance management, Transparency & Reporting, and NDPE IRF progress.

Based on results of the scorecard, ADM engages with direct suppliers to implement time-bound actions to improve upstream activities.

Supplier Compliance Monitoring

The supplier compliance monitoring program began in January 2023. To facilitate ADM's stakeholder engagement process and create the structures necessary for positive supply chain transformation. In practice, Satellite monitoring is performed at plantation level to alert ADM on any violation of ADM's policies to protect Forest. These reports are updated frequently and have an immediate response to deforestation and peat conversion.

NDPE IRF Reporting – Crude Palm Oil

ADM continues to participate actively in the NDPE IRF Working Group to drive progress on reporting against NDPE criteria. ADM has engaged with all its direct suppliers on the provision and improvement of their respective NDPE IRF profiles. As a result of mutual collaboration and engagement with its suppliers, ADM NDPE IRF score in the "Delivering" category significantly improved by 72% between 2023 and 2024.

In June 2024, ADM underwent its annual verification of all its NDPE IRF profiles by an independent third-party. Volumes sourced from January to December 2023 were covered. The audit was conducted in accordance with the NDPE Data Verification Protocol.

NDPE IRF Reporting – Palm Kernel Oil

ADM continues to participate actively to the NDPE IRF Working Group to drive progress on reporting against NDPE criteria. ADM has engaged with all its direct suppliers on the provision and improvement of their respective NDPE IRF profiles. As a result of mutual collaboration and engagement with its suppliers, ADM NDPE IRF score in the "Delivering" category significantly improved by 63% between 2023 and 2024.

In June 2024, ADM underwent its annual verification of all its NDPE IRF profiles by an independent third-party. Volumes sourced from January to December 2023 were covered. The audit was conducted in accordance with the NDPE Data Verification Protocol.

RSPO-Certified Volumes

Certified sustainable palm oil volumes are reported using the volumes of PO and PKO RSPO certified delivered to ADM for in 2023. ADM follows the market demand for RSPO-certified products.

Grievance Management

ADM improved its cooperation with a service provider to investigate on grievances. Thanks to our mutual efforts, it enabled to close some formerlymonitored grievances and reintegrate suspended suppliers that successfully completed a correction plan. Therefore, total closed grievances increased by 8 points of percentage.

All grievances submitted to ADM are investigated :

If allegations revealed to be true and ADM is somehow involved, ADM will react according to its <u>procedure for managing non-compliant</u> <u>suppliers</u>, and engage with stakeholders following the OECD FAO causal relationship framework.

ADM continued its collaboration with direct suppliers regarding their palm responsible sourcing program and measured their performance against ADM commitments. This collaboration is translated into yearly reports that are publicly available online and verified by independent third party.
